The school should go through the provisions of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and retain a copy for reference purpose and is also advised to visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ regularly for updates.
- 4. The School management shall ensure that only CBSE School will be run in the School premises demarcated for the CBSE School and no other institution is permitted in the School premises.
- 5. The School is required to apply online for further extension of Affiliation as per norms of the Board.
- 6. Further, the School is directed not to submit any forged/ fake documents to the Board.
- 7. The Board reserves the right to conduct inspection of school as per clause 11.2 and 11.4 of Affiliation Bye Laws.
- The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to the running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.

"The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms".

The school is required to renew all the mandatory certificates time to time. 5. The school is directed not to remove the videography link in future. 6. The compliance as per POCSO act needs to be updated each year. 7. The Grievances cell needs to be set up as per Board's norms. 8. The school needs to maintain Parent Teachers Association as per Norms School is required to appoint special educator & wellness teacher as per affiliation bye laws.
